**MEDICAID ASSESSMENT REPORT
AS PER HCR 51 2016 REGULAR SESSION**

Description of proposed assessment:

The total assessment for the state fiscal year shall be equal to the state portion of the cost directly attributable to hospitals, excluding federal financial participation, of payments for health care services through the implementation of a health coverage expansion of the Louisiana medical assistance program that meets all the requirements necessary to maximize federal matching funds. The current projected assessment for SFY 2017 is \$29,460,296.

Basis for calculation of the assessment:

Each hospital shall be assessed on a pro rata basis by dividing the total assessment by the total inpatient and outpatient hospital net patient revenue of all assessed hospitals as reported on the Medicare cost report ending in state fiscal year 2015 and multiplying by assessed hospitals total inpatient and outpatient net patient revenue.
