Model Provider Agreement Posting

The Model Provider Agreements for both the CCN-S and CCN-P models will be posted today, August 31st, at www.MakingMedicaidBetter.com. **Many** changes have been made to the original drafts that were posted in June. Therefore entities should carefully review the final agreements. A redline version is being made available to assist with that comparison.

CCN Policy and Procedures Guides

The most current version of the **CCN-P Policy & Procedures Guide** will be posted today, August 31st, at www.MakingMedicaidBetter.com. As with the Model Provider Agreements, many changes have been made to the draft that was posted in July, and entities should carefully review the current version of the **Guide**. A redline version is being made available to assist with that comparison.

The **CCN-S Policy & Procedures Guide** is still being updated and will be posted as soon as the revisions are complete.

Request for Letter of Intent to Enroll as a CCN

The first step of the CCN enrollment process is the submission of a **Letter of Intent** which includes the name and contact information for the primary point of contact during the enrollment process. Please Refer to Section 2 of the **CCN-P Policy & Procedures Guide**. **No other submissions** need to be submitted with the Letter of Intent. DHH is encouraging entities who intend to enroll as either a CCN-P or CCN-S to submit their Letter of Intent **as soon as possible**.

CCN Provider Enrollment (PE-50) Packets

Revised versions of the **PE-50 Provider Enrollment** packets needed to enroll as a CCN-P or CCN-S Louisiana Medicaid Provider Type are being posted today, August 31st, at www.MakingMedicaidBetter.com. A direct link to the required W-9 Form has also been added.

Review of Model Provider Contracts

DHH has developed a **CCN Model Provider Contract Review Checklist**

which is being posted today, August 31st, at www.MakingMedicaidBetter.com. Prospective CCNs can refer to this checklist to determine what DHH will be looking for when reviewing and approving Model Provider Agreements.

CCN Provider Recruitment Materials Review

DHH is requesting that Provider Recruitment materials be submitted to DHH for the opportunity to review and comment. Some materials currently in circulation contain inaccuracies and this review is being providing as a courtesy so that CCNs can avoid unintentional misrepresentation. In addition, these materials are prompting calls by providers to DHH staff. Providing DHH with the materials being distributed will support the successful implementation of CCN efforts for all parties.
