RE: CHANGES IN WORDING FOR SOME WIC FIS

Several changes have been made to some specific WIC Approved food items in regards to how they will be printed on food instruments. Specifically:

- 8th Continent Soy Original Flavor will now say ½ **Gal 8th Continent Soy Any Flavor**- This is to allow participants to choose either the original flavor or the vanilla flavor of the 8th Continent Soy Beverage. Vendors are not required to stock this food item.
- 1 Lb Nature's Own SF Whole Grain will now say **1 Lb WIC Whole Grain Bread** to allow participants to choose among the allowed brands of whole grain breads. Vendors are required to stock this food item.
- We have also added Bumblebee brand Pink salmon as an allowable choice for canned fish, however, the food instrument will continue to print as **5-6 oz cn Pink Salmon OR 5-6 oz cn Tuna**. Vendors are required to stock these food items.

Attached are examples of the new wording that will display on the food instruments. **This change is effective immediately.** The Louisiana WIC clinics are currently being notified of the change in the wording in order to inform participants.
